### Join the first Stream Team Workday of 2022! **April 9 at Davidson Wildlife Unit**

The weather is looking wonderful for Saturday, and we hope you can join us. If you've never done so, know that the work is simple and

plenty of people on hand to help. You may also learn of a new place to drift a fly. For the safety of all, if you or someone in your household is not feeling well, we urge you to stay home.

Please also consider the CDC guidelines for gatherings, including staying up to date with your vaccinations. Thank you for your kind consideration.

**Time**: 9 am to 12 noon (Chapter Approved Sawyers please arrive at 8:30).

Where: We will be working at the Davidson Unit within the Dane County Sugar River Wildlife Area. The Davidson Unit is located just south of Verona on Highway 69 on Oak Grove Rd, 1.3 miles south of Highway 151. There is no road sign for Oak Grove Rd. Oak Grove is the first road past Riverside Rd., then turn right (west) and go about 600 feet to the end of the road, you will see an old stone building on the right. The fire number to put into your navigator is 1855 Hwy 69, Verona, WI. Here is a Google Map link: https://goo.gl/maps/zN17Tg69445as7gG9

What: We will be cutting and treating box elders, honeysuckles, and other invasive woodies to gain access to the river and open up the area so native grasses and forbs can grow. And we will be using the slash to build brush bundles at our next workday on April 30, when it will be much warmer. This will be our third brush bundle installation at Davidson and every installation has been extremely successful. Brush bundles extend and protect the streambank from erosion, and redirected the flow of the river back to the main channel flushing out the silt and exposing the gravel bottom. The brush bundles also provided habitat for young trout. Over the course of a year or so, the brush bundles collect sediment and builds out the streambank.

**Bring:** Bring waders if you want to work in the water or work wet if you want. Spring rains advise muck boots if you have them. Otherwise, there will be plenty of work on dry land. Also bring work gloves, sturdy shoes, and eye and ear protection. Also bring reusable water bottles that can be filled from our 5-gal water jug. Stay hydrated. At this point, masks are not required.

**Parking:** There is plenty of parking by the stone house, which, by the way, was once a stagecoach way station.

**Future Workdays:** 

April 30 - Davidson Wildlife Unit - Sugar River, 1855 Hwy 69, Verona - installing a brush bundle and clearing invasive honeysuckles and box elders

May 14 - Willow Creek - assisting the DNR with a tree planting on Willow Creek in Richland County at Smyth Hollow Rd. and 58 (5.5 miles north of Ithaca).

May 21 - Smith Conley Creek at 2800 Cty Rd H, south of Barneveld - clearing box elders and invasive woodies June 4 - Smith Conley Creek at 2800 Cty Rd H, south of Barneveld - clearing box elders and invasive woodies

#### **President – Mark Maffitt**

I have been an SWTU member for more than 30 years. In the late nineties and early aughts, I served several terms on the board and a couple of terms as vice president. Then I served for eight years as the Newscasts editor back in the days when we snail mailed newsletters to members (yes - Drew Kasel actually has a predecessor). Somewhere in there I also chaired the Icebreaker for a few years. Age and the pandemic time warp makes it difficult for me to say exactly when but I served two additional terms on the board (one term as secretary) just a couple of years ago.

In addition to being a fly-fishing fanatic, I am also a bicycling enthusiast and bicycling advocate. My nonprofit leadership experience includes 14 years on the board of directors (including four years as vice president and then president) of the Bombay Bicycle Club here in Madison. There is a surprisingly large overlap between Bombay and SWTU in terms of the challenges faced by volunteer-driven nonprofits.

There was once an expectation that SWTU vice presidents would subsequently serve as president, but earlier family and career commitments prevented me from fulfilling that expectation. Though it has been a long time, I am thrilled to finally have the opportunity to serve as SWTU president.

#### **Director - Kevin Maes**

Kevin is a lifelong fly fisherman and was fortunate to guide during a summer in Alaska. He's fished all over the US and in many other countries. He's been a TU member on and off for 40 years and believes there is a lot of work to be done to keep this amazing resource going for our children and grandchildren ... and also their grandchildren.

#### **Director - John Freeborg**

John has been a SWTU member since 2016. He started taking the chapter's fly tying courses in 2017 and is still trying to graduate from the intermediate class after many attempts. Learning bug lifecycles through the classes combined with workday stream experiences has kindled a desire to support the chapter's mission in a greater capacity.

At the April 7 meeting, the nominees or a member acting on their behalf will be given the opportunity to present any information relevant to their candidacy.

In addition to the nominees selected by the committee, the chapter bylaws provide that any member may make a nomination from the floor. For those positions with more than one candidate, secret ballots will be used. Thank you to the Nominating Committee: Amy Klusmeier, Curt Reidl and Tom Thrall.

Jim Hess is moving into the Past President role having served his two years as President. A tremendous thanks to Jim for his thoughtful leadership during a most extraordinary time. We're grateful that he will continue to Chair our Conservation Committee.

We would also like to extend our appreciation to Dave Fowler and Ben Lubchansky for their service to the Board of Directors and look forward to their ongoing engagement with the chapter. Ben will continue as Icebreaker Chair and Dave helping coordinate PGT efforts, rod building, fundraising and more.

Note that three directors are in the middle of their two-year term and will continue in their roles: Curt Reidl, Don Golembiewski and Pat Hasburgh.

#### **Proposed Bylaw Changes**

The SWTU Board of Directors asked Bob Selk to review the <u>SWTU Bylaws</u> and propose changes regarding the filling of director positions, making it more manageable, and address the inability to hold in-person meetings, as we have experienced the last two years. Listed below is a brief discussion of these changes and the proposed bylaw amendments. The Board unanimously approved these changes at our February 22, 2022 meeting and recommend their approval at our April 7, 2022 chapter meeting.

#### 1. Provide Greater Flexibility in Filling Director Positions

Discussion: For the past several elections, the Nominating Committee has encountered difficulties in recruiting candidates for the Director position. Specifically, the rigidity of the requirement at Art. 6 (6) of the Chapter Bylaws, which requires that a minimum of two of the six Directors be serving their first two-year term and not have served as a Director or Officer in the eight years prior to the election.

The reason for this provision (and others limiting the length of service on the Executive Board and the Chapter Delegate position) is to avoid entrenched leadership, requiring opportunities for new leadership, and encourage innovation. The board embraces the intent of this bylaw, but finds Art. 6 (6) to be too rigid. The Board's goal is to continue the energy, competence and innovation that has characterized Chapter activities in recent years, while providing more flexibility in the process used to select the leadership.

#### **Bylaw Amendment**

Amend Art. 6 (6) as follows:

At the Annual Meeting, an election shall be held to fill the three Director positions due to expire. The election shall be conducted in a manner that assures that, following the election, at least two of the six Directors, whether elected or appointed, are serving their first term and have not served previously as a Director or Officer in the eight years preceding the election. The nominating committee shall endeavor to include at least one nominee who has not served as Director in the eight years preceding the election

#### 2. Inability to hold Member Meetings In-Person

Discussion: The Chapter has faced challenges in meeting and conducting business during the pandemic. Most ordinary Chapter decision making is conducted by the Executive Board and Officers. The Executive Board has been able to carry on and has met virtually and on occasion has made decisions by other electronic means.

However, the inability to safely hold member meetings has prevented the normal, in person annual election of officers, directors, and the state delegate. The Bylaws plainly contemplate that the annual meeting at which the election is held be conducted in person with the majority of members present and voting deciding the election outcome. See Art. 3 (1) and (4). All other decisions made by the members assembled contemplate the same in person procedure. See Art. 3 (4). The Bylaws do not provide an alternative means to conduct this business when circumstances may require it.

#### **Bylaw Amendment**

Add Art. 3 (6) as follows:

(6) Except under extraordinary circumstances the annual meeting and other member meetings shall be held in person. An extraordinary circumstance includes a present need to protect public health or safety by not requiring members to assemble in person in order to conduct Chapter business. Before holding a member meeting not held in person a finding of extraordinary circumstance shall be declared by resolution approved by two-thirds of the members of the Board and shall include an explanation of the circumstances that require the resolution.

Member meetings not held in person shall be conducted by electronic means in a manner that allows for member participation functionally equivalent to or greater than member participation during an in-person meeting. The process of nominations, presentations, motions, and elections may be carried out over a period of days and voting by members may be done electronically. Other decisions that under ordinary circumstances require a vote of the members assembled may also be made over a period of days.

In person member meetings shall resume as soon as practicable after the Board decides that the extraordinary circumstances have ended.

Below is the process of changing a bylaw.

Article 8 - Procedure for Bylaw Amendment

- (1) Any member may propose to amend the bylaws by presenting the proposed language change in writing to the Board. Within 45 days of receipt of the proposal, the Board shall consider the proposal, develop a recommendation and schedule the proposal for consideration at a membership meeting. Prior to the membership meeting, the membership shall be provided reasonable notice of the language of the proposed amendment and the Board's recommendation.
- (2) At the membership meeting at which the proposal is considered, the language of the proposed amendment may only be changed by the unanimous consent of the members present and voting. However, unanimous consent is not required for a specific language change included in the recommendation of the Board. An approved amendment shall take effect immediately following the vote. (Art. 8)

#### Fountains of Youth

Classic trout flies that have withstood the test of time ... flies that remain "forever young"

The winds of change are often gentle at first, but they freshen with time. Little by little, old ideas fade away, replaced by new ones. Only hindsight reveals when the transition actually occurred. For wet fly fishing in America, the winds of change began in 1941 with publication of The Art of Tying the Wet Fly by James Leisenring. This 81 page treasure introduced Britishstyle soft-hackled flies and methods to American anglers. It was published just three short years after Ray Bergman's 1938 blockbuster book Trout, which included a lengthy examination of wet fly fishing. The colored plates of wet flies in Trout are truly magnificent. Page after page, row after row, hundreds upon hundreds of brightly colored flies. Legendary flies, such as a Leadwing Coachman, Parmachene Belle, and Greenwell's Glory. Smartly dressed soldiers in a vintage army, almost all of which were tied with down wings of matched quill slips. Where are these flies today? Mostly, they're in the unturned pages of old fly tying books and the untraveled corners of old fly boxes. The wet flies pictured in *Trout* are fossils of a bygone era. Headstones of former champions. Leisenring brought a new style of wet fly to America, one as old as fly fishing itself.

"Big Jim" Leisenring (1878-1951) grew up in Allentown, Pennsylvania. A toolmaker by trade, he was tall, bronzed, and spoke with the heavy accent of his German ancestors. He fished the limestone spring creeks of eastern Pennsylvania for over 40 years, all the while refining his knowledge, methods, and flies. Leisenring studied the English and Scottish foundations of fly fishing and read the literature of its great pioneers. But he did not slavishly follow their guidance. Instead, he experimented with the ideas, modified them based on his own experiences, and created a new synthesis for his home waters.

Leisenring kept decades of meticulous notes, but writing did not come easily for him. Fortunately, Leisenring's friends coaxed the reluctant author into writing a brief but very important book. The title page credits "as told to V.S. Hidy" as co-author. Vernon 'Pete' Hidy was a student of Leisenring's who assisted Jim with the book's preparation. Leisenring supplied the genius, and Hidy supplied the clarity. The Art of Tying the Wet Fly established a uniquely American wet fly tradition, causing Leisenring to be often called "The American Skues". The book's impact was modest in 1941, because it appeared amidst the turmoil of World War II. A second edition published in 1971 with Hidy as co-author had much greater influence.

The Art of Tying the Wet Fly is, above all, a fly tying book. Five short pages discuss wet fly fishing. Those few paragraphs describe what has become known as "the Leisenring lift", which Charles Brooks described as "probably the most deadly nymph method known". Like all great masters of the dark arts, Leisenring learned the importance of action and movement when fishing nymphs. Leisenring's soft and feathery flies spring to life in moving water. He was a wizard at seductively manipulating them before trout. The lift was one of many presentations that Leisenring developed. He always intended to write a second book on wet fly fishing, but time ran out before thoughts were reduced to paper. We are all poorer for its absence. Fortunately, Pete Hidy supplied some of the details in a chapter he authored for the 1971 edition. Additionally, Hidy's 1960 book Sports Illustrated Book of Wet-Fly Fishing is an undiscovered gem that expands on Leisenring's and his own wet fly methods.

James Leisenring was, indeed, a fly fishing pioneer. He patiently observed trout and insects, studied the insights of old masters, refined his methods, and quietly shared his knowledge in an influential book rich with the experiences of an expert. Big Jim never sought attention or the limelight, but he is one of America's most original and creative anglers. © Rusty Dunn, 2022

#### ----- Blue Dun Hackle (Leisenring) ---

Leisenring's Blue Dun Hackle is especially useful during hatches of darkly colored mayflies, such as Blue-Winged Olives. Lift it (à la Leisenring) in front of trout feeding deeply, or grease the leader and fish it near the surface to bulgers.

**Hook:** Standard wire nymph hook, #14-20

Thread: Pearsall's Gossamer silk, primrose yellow

Hackle: Light blue-dun hen hackle

**Tail:** Two or three blue-dun hackle fibers

Rib: Very narrow flat gold tinsel

Body: Mole fur spun on primrose yellow silk, a little

of the silk exposed at the tail
